## **I-130 Close Relative (Preference) Petition**

**For other relatives of US Citizens and Lawful Permanent Residents**

### **FEES AND COSTS**

The following fees and costs are typical in a routine Preference Petition visa case from original USCIS filing to visa interview and decision on visa issuance. Fees and costs are payable by bank transfer, international wire transfer or cash.

#### **INITIAL FEES:**

Attorney's fees	60,000 ฿ + 7% VAT (64,200 Baht)
USCIS filing fee	\$355 USD
Courier fees	4,000 ฿

#### **FEES PAYABLE TO THE NATIONAL VISA CENTER (NVC) as of January 2010:**

Immigrant visa fee	\$355 USD
Security clearance surcharge	\$ 45 USD
Affidavit of Support fee	\$ 70 USD

#### **FEES PAYABLE TO 3<sup>RD</sup> PARTIES PRIOR TO INTERVIEW:**

Medical exam fees	Average 5500 ฿ but, may be higher if additional tests, vaccinations or treatment is required.
